Management Discussion of Fund Performance

November 13, 2023

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the ETF's performance and outlook in the six-month period ended September 30, 2023 (the "period"). If the ETF was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the ETF. In addition, net asset value ("NAV") refers to the value of the ETF as calculated for subscription and redemption purposes, on which the discussion of ETF performance is based.

Risk

The risks of the ETF remain as discussed in the ETF's Prospectus.

The ETF is suitable for short- to medium-term investors looking for the current income potential of floating-rate instruments linked to interest rate changes to hold as part of their portfolio to diversify their fixed income holdings, who can handle the volatility of bond markets and who have a low to medium tolerance for risk. The ETF was deemed suitable for investors who had a low tolerance for risk during the period from July 27, 2023, to September 29, 2023.

Results of Operations

Investment Performance

During the period, the ETF returned 5.7% (after deducting fees and expenses). This compares with a return of -4.5% for the ETF's broad-based index, the FTSE Canada Universe Bond Index, and a return of 6.3% for the ETF's narrow index, the Morningstar LSTA Leveraged Loan (Hedged) Index. All index returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

In response to elevated inflation, the U.S. Federal Reserve increased its federal funds rate by 50 basis points over the period to a target range of 5.25%–5.50%. The floating-rate nature of the asset class led to higher interest rates for term loans. Loan prices rose amid expectations the U.S. economy may avoid a significant recession, and loan spreads (the margin by which the interest rate, which fluctuates according to a loan's market price, exceeds the floating reference rate) narrowed.

The ETF outperformed the broad-based index, with its shorter duration (lower sensitivity to interest rates) contributing to performance. Holdings in floating-rate term loans also contributed to performance. Conversely, exposure to real estate sector corporate bonds detracted from performance relative to the broad-based index. Given the ETF's mandate, the return of the narrow index is a more meaningful comparison.

The ETF underperformed the narrow index, with holdings in high-yield bonds detracting from performance. Holdings in real estate sector bonds, overweight exposure to technology sector loans and underweight exposure to consumer finance sector loans also detracted from performance. Conversely, the ETF's overweight exposure to loans rated "B" contributed to performance relative to the narrow index, as did its overweight position in automotive, health care and building products sector loans.

Over the period, the ETF's exposure to term loans and to the United States increased, based on the portfolio management team's assessment of valuations and opportunities, and as a result of market movements.

Net Assets

The ETF's net assets decreased by 14.3% during the period to \$589.3 million. This change was composed primarily of \$35.6 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of \$134.3 million due to net unitholder activity (including sales, redemptions and cash distributions).

At September 30, 2023, 29.8% of the ETF's NAV was held as inventory by the ETF's designated broker primarily for the purpose of sales to investors in the secondary market. As a result of these investments, the ETF is subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effect on the ETF or on its investors, through such processes as settling transactions in kind, charging creation and/or redemption fees for transactions settling in cash, and establishing appropriate order cut-off times for transactions.

Recent Developments

The portfolio management team expects interest rates to remain at elevated levels for longer than initially expected, while economic growth slows because of the impact of earlier central bank rate increases. The team is cautious about high-yield bonds as economic uncertainty challenges credit fundamentals with tighter spreads (the difference in yield between high-yield and investment grade bonds).

The team also remains cautious about term loans because their floating rates have resulted in higher borrowing costs as interest rates rose. Term loans are not shielded from economic risks, and their outlook depends on economic developments and growth expectations. The team believes elevated inflation, high rates and weakening demand could lead to greater market volatility and wider loan spreads.

Related Party Transactions

Management Fees

The annualized management expense ratio ("MER") for the ETF during the period ended September 30, 2023, was similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in the ETF. The MERs are presented in the *Financial Highlights* section of this report. The ETF paid management fees to the Manager at the annual rate of 0.60%.

The management fee for the ETF is calculated and accrued daily as a percentage of its NAV. The ETF's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the ETF, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio and providing other services, and to pay for all costs and expenses (other than certain specified fund costs as more fully described in the Prospectus) required to operate the ETF.

Other Related Party Transactions

Investment funds managed by Mackenzie and its affiliates may invest in the ETF in accordance with the investment objectives of those funds. At September 30, 2023, funds managed by Mackenzie owned 11.5% of the ETF's NAV, funds managed by Canada Life Investment Management Ltd. owned 6.5% of the ETF's NAV, and funds managed by I.G. Investment Management, Ltd. owned 1.5% of the ETF's NAV. All related party transactions are based on the current market price. As a result of these investments, the ETF may be subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effects on the ETF or on its investors, through such processes as settling transactions in kind, charging creation and/or redemption fees for transactions settling in cash, and establishing appropriate order cut-off times for transactions.

During the period, the ETF received \$0.004 million in income distributions from investments in other ETFs managed by Mackenzie to offset fees paid within those ETFs. There is no assurance that these distributions will continue in the future.

The ETF did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions in the period.

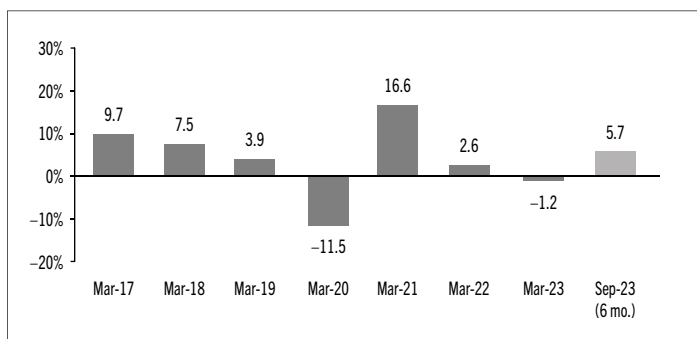
Past Performance

The ETF's performance information assumes all distributions made by the ETF in the periods presented are reinvested in additional units of the ETF. If the ETF was established in the period, the MER is annualized from the date of inception to the end of the period. Where the ETF directly invests in securities of another fund (including other ETFs), the MER presented for the ETF includes the portion of MERs of the other fund(s) attributable to this investment. Any income distributions received from ETFs managed by the Manager, with the intention of offsetting fees paid within those ETFs but which are not considered to be duplicative fees under regulatory requirements, are treated as waived expenses for MER purposes. The Manager may waive or absorb operating expenses at its discretion and stop waiving or absorbing such expenses at any time without notice.

(3) The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net assets during the period. Where the ETF invests in securities of another fund (including other ETFs), the TER presented for the ETF includes the portion of TERs of the other fund(s) attributable to this investment. The Manager may reimburse the ETF for certain brokerage commissions and other transaction costs (including those payable to the custodian or its agents). The Manager may make these reimbursements at its discretion and stop these reimbursements at any time without notice.

(4) The ETF's portfolio turnover rate indicates how actively the ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher the ETF's portfolio turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the ETF. The portfolio turnover rate is not provided when the ETF is less than one year old.
